# IMPORTANT: Playparks, toilet facilities, caravan and camping facilities, and on-site cafes will remain closed at each site due to COVID-19.

Newry, Mourne and Down District Council will re-open Kilbroney Forest Park, Slieve Gullion Forest Park (except for the mountain trail), Delamont Country Park and Warrenpoint Municipal Park on Wednesday 27 May 2020. The parks will be operating on a restricted basis initially, with car parks at each site open from 9am – 5pm each day. Playparks, toilet facilities, caravan and camping facilities, and on-site cafes will remain closed at each site. Visitor numbers entering our facilities will be limited to manage the capacity at each site.

The car parks at Cranfield and Tyrella beaches will re-open from this date. Lifeguards will not be operating on beaches and bathing is not recommended at this time. Council operated harbours will also re-open from this date.

In order to ensure that we can keep our beaches, forest and country parks open for everyone's use and enjoyment we ask that visitors are considerate and responsible in their actions, please follow the latest government guidelines on the COVID-19 response, including continuing to practice social distancing and good hygiene. Please check that facilities are open before you leave home and adhere to the guidance and signage that we've put in place at each site for your safety. Please don't park on grass verges outside of sites, and keep roads clear, especially in rural locations.

All re-opened facilities will be monitored for adherence to the guidance and sites will be closed when it is deemed that adherence to government guidelines around social distancing and good hygiene is not achievable.
