# AHC/43/2020 NOTICE OF MOTION - REFERRED FROM COUNCIL MEETING HELD ON 3 FEBRUARY 2020

Notice of Motion received from Councillor Howell:

"That this Council recognises 2019 saw the North of Ireland experience the highest number of domestic abuse incidents since records began and agrees to work collaboratively with the statutory agencies and health trusts to ensure support and protection of individuals and families experiencing domestic violence be a priority in all Council facilities".

In presenting the motion Councillor Howell highlighted the various forms of Domestic Violence inflicted on anyone irrespective of age, ethnicity, religion, gender or sexual orientation, by a current or former intimate partner or family member. In 2018/19 there were 31,682 incidents of domestic abuse recorded in the North of Ireland, a 10% increase from the previous year and the highest number of incidents in 15 years.

Councillor Howell stated she believed Newry Mourne and Down District Council could aid these statutory and voluntary agencies by taking small measures which would hopefully have an impact on some of the victims lives. This included ensuring staff within council facilities and buildings could avail of ONUS training and were made aware of and kept updated of the Good Practice Guidelines of Recognise – Respond – Refer – Record as outlined by the South Eastern Domestic and Sexual Violence Partnership.

Councillor Howell asked that all council buildings and facilities were recognised as a 'Safe Place' with staff aware of the aforementioned guidelines, including facilities like the recently opened community centres in Saintfield and Castlewellan.

As part of the strategic review on public convenience provision in the district Council should consider placing material in all public conveniences informing users of the domestic violence helpline.

Councillor Mason seconded the Motion, stating it was very timely that the Motion was being put forward with the unfortunate situation with COVID-19 and social isolation.

Councillor McKevitt put forward the following amendment to the motion, accepted by Councillors Howell and Mason.

"That DEAs in this Council encourage the uptake of training for local groups to register their premises as a Safe Place".

Councillor McKevitt urged Council officials to examine alternative arrangements to enable training with the current situation regarding COVID-19.

Councillors Walker, McMurray and Taylor spoke in support of the motion and it was unanimously agreed.
