12.0 Notice of Motion - 'Nip It In The Bud' Campaign

Notice of Motion received from Councillor Galbraith:

"That this Council notes the importance of farmers and rural dwellers to our society; recognises that farmers, agricultural workers and people living in rural communities can have lower access to cancer services due to the nature of their work and often living in isolated areas; we also recognise the impact that a cancer diagnosis can have on a family business such as a family farm, including housing, the extending family and the welfare of livestock; endorses the 'Nip It In The Bud' campaign delivered by the Farming Community Network in partnership with Macmillan Cancer Support and acknowledges the benefits to the rural community; pledges to do all we can to raise awareness and save lives, particularly using our social media platforms, to help rural dwellers in this Council area be aware of the symptoms of cancer and to seek immediate medical advice if necessary, as evidence demonstrates that early diagnosis and treatment can save lives."

13.0 Notice of Motion - Mourne Mountain Gateway Project

Notice of Motion received from Councillor Truesdale:

"This Council notes the recent announcement that the National Trust has paused discussions with Newry, Mourne and Down District Council regarding the Mourne Mountain Gateway Project. The Council further notes the widespread concern expressed by residents across the district, and recognises that progressing this project in the absence of a secured lease presents significant financial and legal risks. This Council therefore agrees to:

- pause all further work and expenditure relating to the Mourne Mountain Gateway Project until clarity is obtained regarding the position of the National Trust;
- undertake a full review of the project, including the exploration of viable and sustainable alternative proposals to the gondola element of the project - such as the development of a visitor centre in Donard Park - to improve access and enhance tourism in the Mournes."

APOLOGIES AND CHAIRPERSON'S REMARKS

Apologies were received from Councillors Gibbons, Rice and Tinnelly.

The Chairperson advised an emergency motion had been submitted and this would be dealt with during the Notices of Motion discussions.

The Chairperson welcomed Councillor Hearty to his first Council Meeting and wished him well.

The Chairperson referenced the devastation that the fires in the Mourne Mountains had caused and praised the volunteers in the frontline services who had worked tirelessly in response to these fires, in conjunction with all Members particularly Councillors Devlin, Clarke and Truesdale. He advised he had asked the Chief Executive and Democratic Services to call a Special Council Meeting inviting departments to come to present their work to date and the plans they had for wildfire prevention when heading into the summer months.

The Chairperson highlighted some of the very successful events he had attended over the last month including:

- The Council's Sports Awards – he thanked the Council staff for organising a fantastic event recognising those sporting heroes across the District.
- Chairperson's Reception held in Kilkeel for Kilkeel High School U14s, U16s and U18s who had won the Ulster Championships in their respective age groupings with thanks to Councillors Hanna and Reilly who were in attendance at the event.
- St Patrick's Day parades in Downpatrick and Newry were a huge success – thanks to the Council staff that took part and organised the event along with the Elected Members who sit on the Committee. He praised the inclusion of the Fireside Stories as part of the events which were a huge success.
- Recognition event for Council staff who were recognized for 40 year service for around 17 members of staff. He stated it was a great night to award these employees and thank them for their service.
- Conference for Ending Violence Against Women – it was an excellent conference which was incredibly moving. He highlighted the work of Women's Aid during the conference which he found very impactful.
- Conference organised by Boster Community – it was an incredible conference celebrating Everyday Heroes.
- There was an exhibition currently being hosted in Down Museum regarding the Oughley Shed. It was a fantastic exhibition and he encouraged people to attend.
- Congratulated Ashgrove Social Soccer Ladies who celebrated International Women's Day and hosted a kickabout in the Newry showgrounds with Dame Mary Peters in attendance.

Ms Taggart advised that any Councillor wishing to attend any conference would be expected to complete a feedback form and return to Democratic Services. This would be circulated to all Councillors for information and to ascertain if a conference was worthwhile and any learning from it.

Councillors Hanna and Taylor welcomed this and Mrs Ward confirmed it would be an item for inclusion on future Council agendas.

In response to a query from Councillor Sharvin in terms of a timeframe for conferences and if Council or the Party leaders grouping considered attendance, Ms Taggart pointed out notification for conferences were generally received well in advance and details should be

forwarded to Democratic Services at the earliest opportunity for Council approval. Councillor Sharvin also spoke of the importance of sharing materials issued at conferences.

Ms Taggart took the opportunity to remind Members she had issued a training needs analysis for completion and asked that this be returned to assist with identifying types of training and conferences elected members should be attending.

Councillors Andrews advised he followed that process for the National Association of Councillors and had information from a presentation on Artificial Intelligence and would forward a copy to Democratic Services for circulation to Members.

The following Motion was received from Councillor Galbraith:

"Noting the contents and lack of detail within the Department of Health's Hospitals - Creating A Network For Better Outcomes document, and expressing its concern that after many years of public campaigning, this Council disputes that no recognition is given to the current Level 2 status of the Downe Hospital, and disagrees with the categorisation of the Downe as similar to other hospitals with minimal service delivery, this Council calls on the Department of Health to consider enhancing the classification of the Downe within its future hospital reconfiguration policy, and for the South Eastern Trust to continually review the potential for the safe enhancement of services at the Downe."

The Motion was seconded by Councillor Sharvin.

In presenting the Motion, Councillor Galbraith said the Health Service was in crisis and it had been known for many years there was a need to transform how services were delivered.

Councillor Galbraith spoke of a depleted workforce and lessons learnt from the COVID pandemic and how this underscored the need for people to be able to avail of treatment where and when they need it most and those involved in the campaign for the Downe Hospital over the years knew how hard a battle that had been and he paid tribute to the Down Community Health Committee.

Members were advised the Downe currently existed as a Level 2 hospital however in within their reconfiguration document, the Department had changed the status of the Downe by categorising it as a "local" hospital. There were currently only three Level 2 hospitals, the Downe, Dalriada and Lagan Valley all with specific needs. The change in status of the Downe by categorising it as a "local" hospital was akin to centres such as the Robinson Hospital, Ballymoney and Moyle Hospital in Larne which were both excellent facilities but very much community care centres and the Downe offered much more than this.

Councillor Galbraith advised a suggestion had been put forward to the Department to consider an additional enhanced category of service for the Downe Hospital and he hoped Members would endorse that call.

Councillor Hanlon queried what was meant by level 2 hospital as she wanted to be clear on what the Motion was asking for. Councillor Galbraith responded that level 2 was same level as a local hospital.

Councillor Enright proposed the following amendment for the Motion to read as follows:

"Noting the contents and lack of detail within the Department of Health's Hospitals - Creating A Network For Better Outcomes document and expressing its concern that after many years of public campaigning this Council calls for the issues around recruitment of staff be resolved in a timely manner to provide for the long-promised 24 hour A and E on the Downe site".

Councillor Lee-Surginor seconded Councillor Enright's amendment.

For Members information, Ms Taggart emailed an extract from a Special Council Meeting in November 2024 when the South Eastern Health and Social Care Trust Chief Executive stated the following:

"Ms Coulter then confirmed that there were no plans to reopen the Downe Hospital Emergency Department, stating that the Bengoa report championed the model to have one major acute hospital at the Ulster Hospital, supported by local hospitals which were Lagan Valley and the Downe. She stated that a consultant led urgent care model was safer for patients, clinically appropriate and sustainable, further stressing the need to be honest and clear with the public about the Trust's plans for the Downe Hospital site".

Councillor Galbraith confirmed he did not accept Councillor Enright's proposed amendment as he believed the Motion was achievable, however he was willing to accept the inclusion of the last sentence to include a 24 hour A&E service at the Downe.

It was agreed on the proposal of Councillor Hanlon, seconded by Councillor Hearty to have an adjournment.

The meeting was adjourned – 7.05pm
The meeting did then resume - 7.15pm.

Councillor Sharvin took the opportunity to clarify Councillor Galbraith's motion and that within Department of Health's Hospitals - Creating A Network For Better Outcomes document the Downe had been associated with other centres like Bangor and Ards Community Hospitals and the Robinson Hospital. He explained the Motion was aiming to remove the opportunity for the Trust to strip even more services away from the Downe and being associated to lesser hospitals right across the north.

He added the suggestion for 24hour by 7 A&E to be included within the motion was to be welcomed rather than removing the substantive motion. He said there was a need to protect what services were there and by removing the wording as suggested by Councillor Enright would reduce that protection, and what was being asked for was the correct status of the Downe to be acknowledged and not being associated with other hospitals that were under that categorisation.

Councillor Sharvin said he wanted to see services enhanced in a safe manner and through the proper review process and to just go for recruitment of the A&E did not take into consideration all the other services that the Downe delivered.

In thanking Councillor Galbraith for tabling the Motion, Councillor Hanlon put on record thanks to the staff at the Downe Hospital who provided a fantastic service to the local

community and also to the Down Community Health Campaign. She added Sinn Féin were supportive of any proposal that would enhance services at the hospital but noted concerns that the document cited had little mention of the Downe Hospital given the services it provided.

Councillor Hanlon stated to remove the full body of the motion would not be sensible as it would make it just an A&E issue, while important, it was required that all stakeholders need to look at what the Community actually wanted. She wanted to be clear that Council were not just asking for A&E provision but for enhancement right across all services.

Councillor Enright responded by stating a large number of services had moved to the Downe Hospital over the last number of years including services of regional importance and the key obstacle to more services being transferred was the absence of the promised 24 hour A&E service.

Councillor Enright said the problem with not having the A&E service as promised and which was budgeted for, was that services like mental health could no longer be based in the Downe. There was a need to focus on what really mattered to the local people and being able to have a 24 hour accessible A&E which facilitated other services which were currently blocked from coming to the Downe on the grounds there was no A&E.

Councillor Sharvin questioned if Councillor Enright did not recognise that in the body of the Motion as presented by Councillor Galbraith that the categorisation of this particular level potentially removed some of those regional services from the Downe and if not given the right category those regional services may not continue to exist.

Councillor Hanlon implored Councillor Enright to include the body of the Motion as it was calling for enhanced services and said it was dangerous of him to say there was no mental health services in the Downe given that Council had only recently called for the restoration of services at Shimna House, Ward 15 which was a mental health unit for addictions.

The Chairperson put Councillor Enright's amended Motion, seconded by Councillor Lee-Surginor to a vote, the results of which were as follows:

FOR:	5
AGAINST:	32

The Chairperson declared the amended Motion was lost.

Councillor Jackson stated the DUP recognised the health service was undeniably the most precious of public services and there was a responsibility on everyone to work together to make health and social care in Northern Ireland a success and ensure services and structures effectively met the needs of the changing population. As a Party, they stood ready to work alongside the Health Minister, clinicians and staff, local communities and patients to improve and transform outcomes for all and no services should be removed without strong local consultation and input.

Councillor Hanlon reiterated Sinn Féin's position on the Motion and noted her disappointment with the Alliance Party at not taking the opportunity to back Council support for enhancing the hospital services.

Councillor Taylor spoke on support of the Motion and acknowledged the strong community support for the Downe hospital, a vital part of the health service within the District and as elected representatives should take the opportunity to make stronger representations to protect and enhance the delivery of services at sites like the Downe.

Councillor Sharvin proposed an amendment, seconded by Councillor Hanlon for the Motion to read as follows:

*"Noting the contents and lack of detail within the Department of Health's Hospitals - Creating A Network For Better Outcomes document, and expressing its concern that after many years of public campaigning, this Council disputes that no recognition is given to the current Level 2 status of the Downe Hospital, and disagrees with the categorisation of the Downe as similar to other hospitals with minimal service delivery, this Council calls on the Department of Health to consider enhancing the classification of the Downe within its future hospital reconfiguration policy, and for the South Eastern Trust to continually review the potential for the safe enhancement of services **including a 24x7 A&E service at the Downe.**"*

NOTICE OF MOTION – REMOVAL OF RED TELEPHONE BOXES

The following Motion was received from Councillor Lewis:

*"Council Notes with Concern the Removal of Red Telephone Boxes
This Council notes with concern the impact of BT's decision to remove a number of red telephone boxes across the district. These iconic telephone boxes hold historical and cultural significance within our communities, and their removal would represent a loss to the character of our towns and villages. The Council further notes the imminent removal of these telephone boxes and expresses support for their retention in prominent locations where feasible. In light of this, the Council seeks to explore options for the adoption of these telephone boxes for community use through BT's 'Adopt a Kiosk' scheme at a limited charge. The Council calls for an investigation into the potential repurposing of these telephone boxes to serve community needs, including their use as defibrillator stations, book exchanges, or local information hubs, and urges engagement with BT and relevant stakeholders to facilitate this process".*

The Motion was seconded by Councillor Bowsie.

In presenting the Motion, Councillor Lewis spoke of how something small, yet instantly recognisable, the iconic red phone box added to the historic and picturesque nature of villages and towns and how the bright red booths were more than just a place to make a phone call. They were a piece of history, which local communities were proud of, often kept, maintained and looked after by the communities locally.

Councillor Lewis spoke at length of the history of red phone box with the first one known as the K2 being designed in 1924 by Sir Giles Gilbert Scott and how over the decades, newer models like the K6 became more common and placed all over the UK, especially during King George V's Silver Jubilee.

Councillor Lewis advised he was asking Council to produce a report as to how it could help local communities that wished to keep or repurpose phones within areas identified by BT.

In seconding the Motion, Councillor Bowsie commended Councillor Lewis for his efforts in saving and encouraging the appreciation of the iconic red telephone boxes dotted throughout the UK and provided Members with a breakdown of where the red phone boxes were located within the District.

Councillor Campbell spoke in support of the Motion and how it was something that impacted the community he represented, especially in Strangford where there was a strong community bond with the kiosk.

Councillor Truesdale confirmed her party were than happy to support the Motion and queried if there was information on the specific red paint you have to use and the refurbishment of steel frames for the windows.

Councillor Taylor, in voicing support for the Motion, agreed the red telephone boxes were an important part of local heritage and any town or village and it was regrettable that BT were seeking to remove them from areas across the District.

Councillor Sharvin confirmed the SDLP fully supported the motion and how they provided access to communication for those that needed it.

Councillor Sharvin suggested Council write to BT to express to them that Council was carrying out this piece of work and ask that they halt any removal until Council had completed the exercise.

The Chairperson declared the Motion was unanimously passed.

Councillor Lewis thanked Members for their support for the Motion.

Agreed: **It was agreed on the proposal of Councillor Lewis, seconded by Councillor Bowsie that Council notes with Concern the Removal of Red Telephone Boxes.**

NOTICE OF MOTION – PARAMILITARY GROUPS TRANSITIONS FROM VIOLENCE AND CRIME

The following Motion was received from Councillor Howie:

“That this Council categorically opposes proposals from the UK and Irish Governments to appoint an independent expert to scope out a new process of engagement for to bring about paramilitary group transitions to disbandment; agrees that, more than 25 years after the signing of the Good Friday Agreement, there is no place for paramilitarism in our society, and that such groups should either immediately disband or face a robust law enforcement approach like other organised crime gangs; welcomes the work of the Executive Programme on Paramilitarism and Organised Crime; and agrees to write to the Secretary of State for Northern Ireland and the Taoiseach to call for them to abandon plans for this paramilitary transition scoping and engagement exercise and reinvest the associated funding in law enforcement approaches to paramilitary activity”.

The Motion was seconded by Councillor Truesdale.

In presenting the Motion, Councillor Howie said having been born after the Good Friday Agreement she had grown up in a post-conflict society and that paramilitarism and violence had no place in society.

Councillor Howie stated the idea to now appoint an independent expert to scope out a new process of engagement with paramilitary groups, rather than reinforcing a clear and lawful path to disbandment sent the wrong message. It risked legitimising those who continued to exploit and threaten communities, especially young people.

Councillor Howie stated Council must send a clear message, one that supported peace, justice and accountability and write to the Secretary of State and the Taoiseach to oppose these proposals and call for funds to be redirected to robust, front-line action against paramilitary activity.

Councillor Hearty proposed the following amendment:

*“That this Council **notes the proposals from the British and Irish Governments** to appoint an independent expert to scope out a new process of engagement to bring about paramilitary group transition to disbandment; agrees that, more than 25 years after the signing of the Good Friday Agreement, there is no place for paramilitarism in our society, and that such groups should either immediately disband or face a robust law enforcement approach like other organised crime gangs; **welcomes the work of the Executive Programme on Paramilitarism and Organised Crime; and calls on the British and Irish Governments to set out a short and strictly limited timeline for the scoping and engagement exercise”.***

Councillor Hearty said he had no doubt that most of the Members would agree with many of the points in the Motion but it did not make sense to limit approaches when it came to tackling paramilitarism. Almost 30 years past the Good Friday Agreement, and despite what may be claimed, no armed group that existed today had any political purpose or legitimacy and the armed groups that remained active were doing nothing more than using the conflict of the past as a cloak to cover up their true purpose, which was organised criminality.

Councillor Hearty said many would agree with the overall sentiment of the Motion however it should not be limited to a single approach and should not be dismissed but rather it should be tested and urged Members to support the Sinn Féin amendment.

The Chief Executive referred to Standing Orders and advised any amendment must not be a direct negative.

It was agreed on the proposal of Councillor Sharvin, seconded by Councillor Finn to have an adjournment.

The meeting was adjourned – 7.55pm
The meeting did then resume – 8.08pm

In response for clarity from the Chairperson, Councillor Hearty confirmed that in accordance with Standing Orders he would withdraw the amendment and unfortunately due to the wording of the Alliance Motion, Sinn Féin would not be able to support it but fully agreed with the sentiment of it.

Councillor Taylor stated on behalf of his party there was no place for paramilitary gangs and they should disband immediately. He said that whilst he agreed with the sentiment of the Motion it was premature, not in the sense not to get rid of paramilitaries but to find out exactly what was being planned and then take time to make a decision. He added there should be no concessions to incentivise any transition and nobody should be above the law and any past crimes could not form any part of any new process that aimed to bring about transition to disarmament and any the proposal by the UK and Irish Governments should ensure that agencies such as the Paramilitary Crime Task Force, PSNI, National Crime Agency and HMRC continued their work through any process taken forward.

Councillor Jackson stated the DUP recognised that political parties, Executive departments and the criminal justice system had a collective responsibility to challenge the existence of paramilitary organisations and it remained their position that where there was evidence that any individual was a member of a proscribed organisation or was otherwise involved in criminal activity should face the full rigour of the law.

He said the independent expert appointed should be given the time and space to conduct their work and part of that scoping exercise would gauge levels of support for such a process and capture not just the appetite for engagement by paramilitary organisations but those impacted or victimised by their unacceptable activities.

He wished to make it clear that the concept of transition could only occur where individuals or organisations were fully committed to leaving their past behind and there was a need for caution and safeguards to avoid any perception that transition rewards paramilitaries.

The Chairperson put Councillor Howie's Motion, seconded by Councillor Truesdale to a vote, the results of which were as follows:

The following Motion was received from Councillor Hanlon:

“This Council recognises the cost-of-living crisis continues to have a deep impact on workers and families and our most vulnerable; Acknowledges that planned cuts announced by the British Government to the welfare benefits system are attack on the most vulnerable in our community and we must stand together against them; Notes the concern that since coming into office that this British Government has targeted the most vulnerable by cutting winter fuel payments and entitlement to Personal Independence Payment; In voicing our opposition to these cuts; This Council will publicly outline our opposition as a voice of our citizens; We will write to the British Government outlining our opposition and calling for them to reverse this decision; and we will actively engage with groups and organisations working in this field to give public expression of our opposition to these cuts”.

The Motion was seconded by Councillor Magennis.

In presenting the Motion, Councillor Hanlon stated Council would publicly outline its opposition and write to the British Government calling for them to reverse the decision and actively engage with groups and organisations working in this field to give public expression of opposition to the cuts and yet another callous act.

Councillor Hanlon stated austerity was a political choice and if money could be found for weapons of war and mass destruction, then money could be found to support people into employment whilst protecting those were unable. She added this was another blow after previous cuts by Labour since taking up office including the winter fuel payments for pensioners, it was clear interest lay with the wealthy and elite and not those in society who were struggling through no fault of their own.

Councillor Hanlon reminded Members that this Labour government had led an all-out assault on the elderly, family farms, small businesses and now the disabled and once again this

highlighted the need to build a new and united Ireland where decisions were made in the best interests of workers, families, the vulnerable and communities.

Councillor Finn thanked Councillor Hanlon for bringing the motion given the impact that this decision would have for so many of the most vulnerable across the District. She said like many in the chamber she worked in a constituency office and spent time supporting constituents who come for assistance with PIP forms, often already distressed by the lengthy process and have been plunged into even more anxiety following the announcement a number of weeks ago.

Councillor Finn said SDLP supported the motion and whilst it was fair to say nobody expected the Executive to mitigate the estimated £150m to cover these costs, they could not wash their hands of the situation. Many of the proposed changes would not come into effect imminently, buying important time to work on and put mitigations in place.

Councillor Finn proposed an amendment, seconded by Councillor Andrews for the Motion to read as follows:

*"This Council recognises the cost-of-living crisis continues to have a deep impact on workers and families and our most vulnerable; Acknowledges that planned cuts announced by the British Government to the welfare benefits system are attack on the most vulnerable in our community and we must stand together against them; Notes the concern that since coming into office that this British Government has targeted the most vulnerable by cutting winter fuel payments and entitlement to Personal Independence Payment; In voicing our opposition to these cuts; This Council will publicly outline our opposition as a voice of our citizens; We will write to the British Government outlining our opposition and calling for them to reverse this decision; **commits to writing to the First and Deputy First Minister asking them to lobby the UK Government to reverse changes that will negatively impact vulnerable people; further commits to writing to the Minister for Communities to prepare, with the support of Executive colleagues a business case for a mitigation package which provides protections for current and future claimants from reductions in social security entitlements outlined in the Pathways to Work Green Paper**".*

Councillor Hanlon accepted Councillor Finn's amendment stating categorically that this lay with the British Government and that the business case for a mitigation package went to the them.

Councillor Truesdale proposed an amendment, seconded by Councillor Young for the Motion to read as follows:

*"This Council recognises the cost-of-living crisis continues to have a deep impact on workers and families and our most vulnerable; Acknowledges that planned cuts announced by the British Government to the welfare benefits system are attack on the most vulnerable in our community and we must stand together against them; Notes the concern that since coming into office that this British Government has targeted the most vulnerable by cutting winter fuel payments and entitlement to Personal Independence Payment; In voicing our opposition to these cuts; This Council will publicly outline our opposition as a voice of our citizens; We will write to the British Government outlining our opposition and calling for them to reverse this decision; commits to writing to the First and Deputy First Minister asking them to lobby the UK Government to reverse changes that will negatively impact vulnerable people; further commits to writing to the Minister for Communities to prepare, with the support of Executive colleagues a business case for a mitigation package which provides protections for current and future claimants from reductions in social security entitlements outlined in the Pathways to Work Green Paper; **following decision and we will actively engage with groups and organisations working in this field to give public expression of our opposition to these cuts. Also calls on the UK Government not just to reverse the cuts***

but to increase taxes for the super wealthy as an alternative means of generating revenue that doesn't take away support from those who need it".

Councillor Hanlon accepted Councillor Truesdale's amendment.

Councillor Reilly advised the DUP agreed largely with the sentiment of the motion and commended MP Lockhart for emphasising at Westminster the fact that under the new provisions, that for someone with a mental health condition that had qualified for PIPS it would be almost impossible to receive that now. He spoke of the unfairness of people who had lived and contributed to the system in the United Kingdom to have that spent on schemes for migrants.

In speaking in support of the Motion, Councillor Taylor referred to his work as a welfare support officer and dealing with some of the most vulnerable in society and how the impact of continued changes to the welfare system over recent years was causing fear and despair to those in need within communities. He added anyone in receipt of disability benefits deserved some stability and a level of support that allowed them to live their lives without the constant fear and challenge.

Councillor Andrews voiced support for the Motion and spoke of those impacted by welfare reform having witnessed the fear and trepidation regarding PIP. He also spoke of how PIP forms were constructed and how the Scottish model was a better system to operate with PIP and welfare claimants who needed help the most.

Councillor Bowsie commended Councillor Hanlon for bringing the Motion and the Communities Minister Gordon Lyons, MLA who had recently announced £17million to ensure every pensioner in Northern Ireland received some energy support this winter.

The Chairperson declared the Motion was unanimously passed.

Councillor Hanlon thanked Members for support for the Motion expressing concern that people felt that there was no point in applying as they felt they now would not receive PIP and that was a very worrying trend with vulnerable people being left even more destitute. She also welcomed and acknowledged the Communities Minister for the winter fuel payment that had been mitigated against.

Councillor Feehan stated Newry Canal once fuelled trade and prosperity and with vision and commitment, it could do so again and urged Council to reimagine Newry Canal, not as a forgotten waterway, but at the heart of a renewed and prosperous community.

society suffering from endometriosis who have been ignored, or made to feel that their symptoms were exaggerated, affirms that menstrual taboos are unhelpful and detrimental to our society, will write to the Department of Health to seek an update on the efficacy of relugolix combination therapy, and seek views on the possibility of its introduction here, and commits to ending menstrual taboos in this District to allow women the space to be heard and believed when discussing menstrual health."

The Motion was seconded by Councillor Finn.

In presenting the Motion, Councillor Devlin advised she spoke not only as an elected member but also as someone who understood the personal struggles that many women faced with endometriosis and other chronic gynae conditions. Members were informed March had been Endometriosis awareness month and April Adenomyosis awareness month and these were conditions she had not heard of until her own diagnosis with both.

Members were informed Endometriosis occurred when tissue similar to the uterine lining grew outside the uterus with symptoms that could include painful periods, chronic back and abdomen pain, fatigue and even Infertility and Adenomyosis occurred when uterine lining tissue grew into the uterine wall, a condition often causing unbearable pain.

Councillor Devlin made reference to the two tiered system with those stuck on a never-ending NHS waiting list and those who were able to go private which was completely wrong. Endometriosis was a very common condition but one that often went undiagnosed and there should be a breaking the taboo when it comes to menstrual health.

Councillor Devlin spoke about the need for and absence of a Women's Health Care Strategy in Northern Ireland which was fully funded with specific targets. She added it was crucial to advocate for better treatment options and support systems for women and by supporting the motion affirm commitment to improving menstrual health, breaking down barriers and ensuring every woman feels validated and supported in her health journey.

In welcoming the Motion, Councillor O'Hare spoke of the lack of awareness, delayed diagnosis and lack of access to appropriate treatment which meant women suffer needlessly with an extremely painful and debilitating disease that can result in limited mobility, regular episodes of violent vomiting and extreme, life-altering pain.

Councillor O'Hare stated access to treatments that could alleviate symptoms was so important and as a Council it must support that the NICE recommendations were implemented in the North.

Councillor Lee- Surginor spoke in support of the Motion having known someone who faced chronic pain with the condition and to hear of a therapy definitely represented a significant advancement for those who had explored multiple other interventions without much success and looked forward on receiving a response from the Department of Health regarding the efficacy of the therapy and exploring the possibility of introduction here in Northern Ireland.

In voicing support for the Motion on behalf of their respective party's Councillors Taylor and Hanna commended Councillor Devlin for highlighting the debilitating condition for women.

The Chairperson declared the Motion was unanimously passed.

Councillor Devlin thanked Members for their support for the Motion.

The following Emergency Motion was received from Councillor Clarke:

“This Council voices their grave concern over the most recent spree of gorse fires across the Mourne Mountains.

This Council acknowledges the devastating impact these fires have had on our rural countryside and will write to DAERA Minister calling on him to bring forward a comprehensive management plan.

This Council commends the work of local authorities in combating these devastating fires, with firefighters from across the North battling the flames to protect life and property. Recognises the ongoing preservation work from The Forever Mournes Partnership.”

The Motion was seconded by Councillor Devlin.

In presenting the Motion, Councillor Clarke said the deliberate wildfires in the Mourne Mountains were nothing short of a heinous act against nature and the community which not only devastated the beautiful landscapes and habitats to countless species but also posed severe risk to human life and property. He said the intentional destruction of such a precious natural resource was utterly reprehensible and could not be tolerated and it was imperative

that those responsible were held accountable and that efforts were strengthened to prevent such senseless acts of environmental vandalism in the future.

Councillor Clarke referred to April 2021 when fire ripped through the Mourne and there was promised prompt action and a comprehensive fire prevention and management plan to ensure such devastation could never happen again but the same nightmare was being faced. The Mourne were on fire once more with terrified people having to be evacuated from their homes in the middle of the night.

Councillor Clarke stated four years on, a robust fire prevention management strategy that was pledged still lacked. He expressed his thanks and gratitude to the Fire and Rescue personnel who had battled 146 fires in recent days in difficult terrain and conditions to get blazes under control with the emergency far from over with the Mourne still burning.

Councillor Clarke added that with the Easter holidays approaching, everyone needed to be vigilant and Council and other statutory and environmental organisations needed to work in partnership to ensure the Mourne were respected by visitors and locals alike.

Councillor Clarke advised he was calling on the Minister to urgently review the current 'burn period' and to deliver on the promise of a Fire Prevention and Management Plan for the Mourne. This was not just about protecting the natural heritage but about safeguarding communities, biodiversity and the future of the environment. The ongoing fires posed severe risks to health, the environment and the species that inhabit the lands. The Mourne were home to a variety of species, many of which had been severely impacted by the fires and the destruction of habitats and the impact on the tourism product was of significant concern.

In seconding the Motion, Councillor Devlin acknowledged how difficult the weekend had been and paid tribute to the Fire and Rescue Service and volunteers on the ground who took risks to protect the community. She also referred to the fires in April 2021 when the Mourne burned for days and it was happening again with lives and homes at risk, widespread environmental damage and loss of wildlife. She welcomed that the Chairperson had called for a Special Council Meeting as it was so important to hear from the different departments in terms of what had been done since 2021 as a lot was promised at the time and strongly urged action from central government.

Councillors Taylor, Hanna, Truesdale, McAteer and Reilly spoke at length in support of Motion on behalf of their party's and paid tribute to the Fire and Rescue personnel and volunteers who had worked tirelessly to contain the fires.

The Chairperson declared the Motion was unanimously passed.

Councillor Clarke thanked Members for their support for the Motion and as previously eluded to by Councillor Hanna to this was a risk to like and someone would die if things did not change.

Agreed: It was agreed on the proposal of Councillor Clarke, seconded by Councillor Devlin that Council voices their grave concern over the most recent spree of gorse fires across the Mourne Mountains. Council acknowledges the devastating impact these fires have had on our rural countryside and will write to DAERA Minister calling on him to bring forward a comprehensive management plan. Council commends the work of local authorities in combating these devastating fires, with firefighters from across the North battling the flames to protect life and

property. Recognises the ongoing preservation work from The Forever Mournes Partnership.”

Councillor Truesdale thanked Mr Scott for the comprehensive and detailed report and spoke of two recent examples of good practice of Council being trauma informed.

Councillor Truesdale spoke at length about trauma and how the need for a trauma informed approach was greater here because of post conflict society and people living within the District with different backgrounds including refugees and asylum seekers who had escaped unimaginable horrors and ethnic communities who had been threatened or attacked in their own homes, as well as those who had experienced trauma either directly or intergenerational.

Councillor Truesdale paid tribute to the work of officers and Councillors including those who were Members of the Good Relations Forum, PCSP and sub committees.

In response to a query from Councillor Truesdale regarding specific training for new Councillors since being elected and before 2023 across Council, Mr Scott advised there had been a Local government e-learning platform for Members and staff and Council had moved on to a new provider about a year ago.

Mr Scott advised he sat on the Safeguarding Board for Northern Ireland (SBNI) Trauma Informed Practice Committee and one of the things being worked on was the upgrading and improving of the training package and there would be new training programmes including face to face training and an e-learning package that would be implemented moving forward.

Councillor Truesdale spoke of lone workers within Council who faced difficult situations e.g. dog wardens and how those who had to face such situations in people's homes or businesses and how they should be considered when it came to trauma informed care.

Mr Scott agreed and confirmed that there was role for a wider duty of care and management responsibility that would be part of the process and in upgrading policies that

would be taken into account as part of that process. Mr Scott advised he welcomed people to contact him in his role as Safeguarding Co-ordinator.

Councillors Andrews, Lee-Surginor, D Murphy and Lewis voiced support for the commitment to trauma informed practices.

Council at its March meeting carried the following motion:

This Council:

- Notes that under current Northern Ireland road traffic law, there is no legal requirement for other vehicles to stop when a school bus is picking up or dropping off pupils.
- Recognises that child safety is of paramount importance and that measures akin to the U.S. “stop-arm” system—requiring traffic to halt while schoolchildren board or alight—could significantly reduce the risk of accidents and injuries.
- Highlights the growing public concern and the desire of parents, educators, and local communities for stronger safeguarding measures at school bus stops, especially in rural areas where road layouts can pose additional risks.
- Believes that introducing legislation mandating vehicles to stop when a school bus is actively loading or unloading students would enhance road safety and offer additional protection to schoolchildren across Northern Ireland.

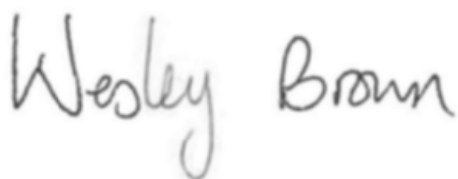
This Council Resolves To:

- (i) Call upon the Northern Ireland Assembly to develop and pass legislation requiring vehicles to stop for school buses that are picking up or dropping off pupils, in line with best practices observed in other jurisdictions.
- (ii) Write to all other local councils in Northern Ireland, urging them to support and pass similar motions, thereby demonstrating widespread local government backing for this measure.

- (iii) Write to the Minister for Infrastructure and the Minister of Education, highlighting the need for such legislation and requesting that they prioritise this issue within the Executive; and
- (iv) Undertake any additional measures within Mid-Ulster District's remit—such as awareness campaigns or pilot schemes—aimed at strengthening school transport safety until statutory changes are in effect.

I would appreciate your consideration in this important matter and would be grateful for a response.

Dear Marie

I am responding on behalf of the Cabinet Secretary to your letter of 10 March 2025 which expressed concern about access difficulties to skilled worked visas for Northern Ireland's fishing industry.

Scottish Government has also consistently called on the UK Government for changes to Skilled Worker Visa provision to be made to ensure that route is genuinely proportionate and accessible to all parts of the fishing fleet. While we would not otherwise wish to prolong the use of transit visas given their wider detrimental effects, the 2023 visa changes produced a significant change in workforce availability for the Scottish fishing industry, and within the wider seafood supply chain.

Scottish Government will continue to look to collaborate with the UK Government, and alongside DAERA, to address labour shortages given the significant impact this continues to have on our fishing industry.
