**1. Apologies and Chairman's Remarks**

Apologies were received from:-

Audrey Byrne, Laura Devlin and Fiona Stephens.

**2. Crimestoppers Presentation**

The Chairperson welcomed Mr Greer Parkinson to the meeting and invited him to make his presentation.

Mr Parkinson thanked the Committee for the invitation to present stating he was a voluntary board member of Crimestoppers NI which was the only charity helping to solve crime in Northern Ireland.

He stated that people associate Crimestoppers as being part of the Police service however they were not and it had been decided to remove their number off police vehicles. Once this occurred, it was noticed that there was a decrease in the numbers of calls so it was decided to put the number back onto vehicles along with the word anonymous.

Mr Parkinson advised Crimestoppers initiative began in New Mexico in 1976 and there were currently 1300 operations worldwide with Crimestoppers NI being 20 years old next year.

The Chairperson thanked Mr Parkinson for his presentation (copy can be shared with members) and invited questions from Members.

Members raised the following questions:

- How successful were calls in helping to bring people to justice and were there many vindictive calls made?
- Many people were not aware that Crimestoppers was a charity and had nothing to do with police, would they not advertise on the vehicles that it was a charity?

Mr Parkinson responded to the queries as follows:

- PSNI members analyse statistics and receive feedback on what effect campaigns run by Crimestoppers have on crime levels. The 'Drug Dealers Don't Care' campaign was one of the most successful in Northern Ireland and although it was hard to see full success, the receiving of one call can help Police piece a jigsaw together.
- Most of the vindictive calls would be filtered out by operators. Calls are generally relevant to what was being searched for through social media etc.
- People still think it was the confidential telephone number which was run by Police however generally down to funding there was only so much room on the vehicles and now that anonymous was being added there wouldn't be any additional space.

DCC Harris advised he had previously worked with Crimestoppers and with very serious crimes 1 or 2 calls can be exactly what Police were looking for and lead to convictions. He stated it was easy to make the link with Police however now that the PCSP knew it was a charity they should publicise it.

The Chairperson thanked Mr Parkinson for his presentation.

**8. Officer Report**

Read: Report by Siobhan Fearon dated 24 January 2017, regarding the Officer Report. (copy circulated)

Terry Andrews referred to anti-social behaviour in the Killyleagh area, particularly arson attacks and asked whether Killyleagh could be one of the areas for a roll out of an action plan.

Siobhan Fearon advised part of the work programme going forward would be to tackle hotspots based on baseline evidence. In meantime Community Safety Wardens covering Killyleagh on their shifts.

Mickey Larkin asked whether some support could be given to the local youth worker in Jonesborough as there had been a spike in anti-social behaviour, vandalism and threats. A youth club had been set up in the area under the youth workers were under severe pressure.

The Chairperson advised this could be something that could be raised within the DEA Fora.

Jude Cumiskey asked for an update on the Bonfire Liaison Committee.



Siobhan Fearon advised a meeting would be set up within the next couple of weeks. She stated they were continuing to look at best practice models from other areas.

Willie Clarke asked whether people were engaging with the "Coffee with the Cops" initiative.

Andrew Kernaghan advised the engagement depended largely on where the initiative was taking place, sometimes down to the coffee house it was being held in.

Ewan Morgan stated he had brought a member of the public to one of the 'coffee with the cops' a number of months ago and no one from PSNI had shown up. Superintendent Reid advised this was addressed at the time and there was rationale for why the Police didn't turn up, however they had given an undertaking to resources these events.

S Fearon repeated the rationale behind coffee with cops was high visibility and engagement opportunity for PSNI with public, not a clinic and not about individual cases. If such an instance arose arrangements would be made with PSNI to speak to individuals in a more private capacity.

Fergal O'Brien stated there were members of the Bulgarian community who had been receiving evictions however they had no recourse to funds in order to get back home to Bulgaria and he wondered where they can go when evicted.

Superintendent Reid stated that if individuals for repatriation present themselves to Police, they would work with whichever agencies were responsible for providing the repatriation service to ensure the people in question get back to their own countries.

Fergal O'Brien outlined that all carers were legally entitled to carer's assessment from social workers.

Una Kelly asked for clarification on how her role on PCSP fitted into that of the DEA when there had been a public DEA Meeting held in Strangford and as an independent member of PCSP, she felt she should have been asked to carry out some preparatory work throughout the Strangford area to encourage members of the public to attend the meeting.

Siobhan Fearon stated this was a very new process for everyone however all DEA Forum dates and venues had been circulated to PCSP Members who had been encouraged to attend. She advised each DEA had its own action plan and PSCP officers and the DEA coordinators were working closely to ensure that there was not replication of work being carried out. The relevant parts of DEA action plans were also considered at the review presentation in January in Canal Court.

Grace McQuiston asked whether the 'wishlist' on the DEA action plans was actually realistic and how much of it could be delivered.

Siobhan Fearon advised a model of evaluation and standard would be applied across the action plans and feedback would be collated on what the action plans were doing and why.

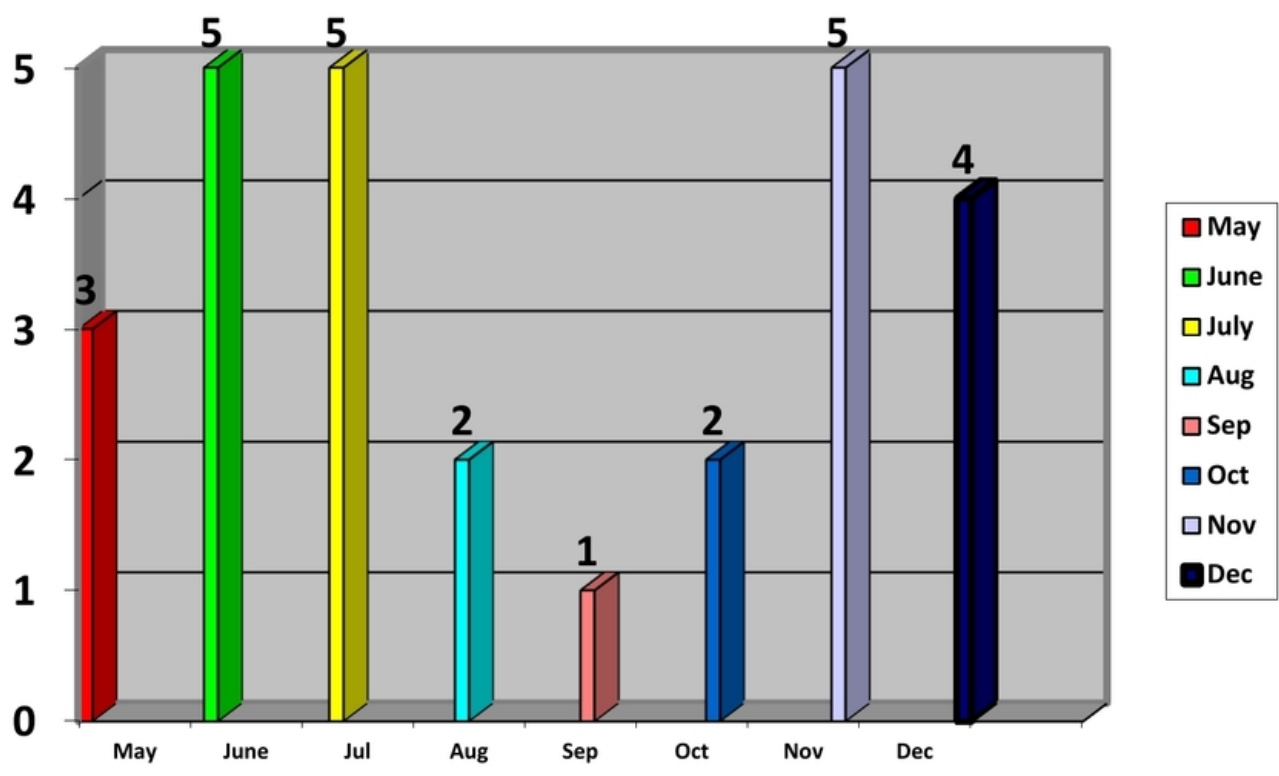

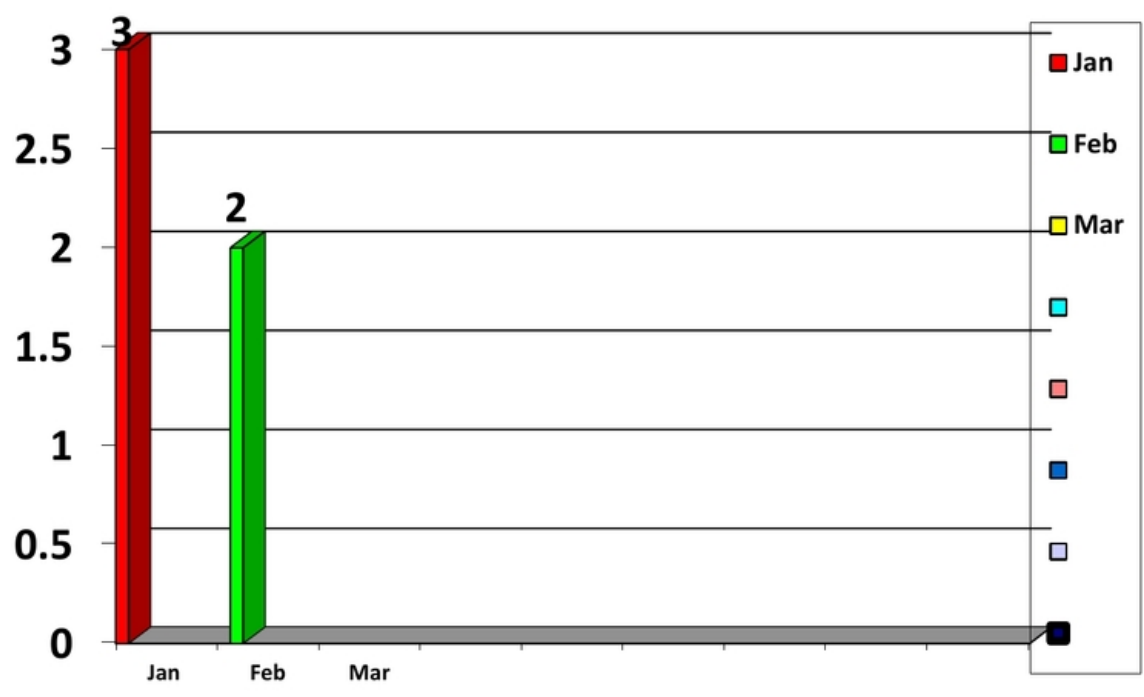

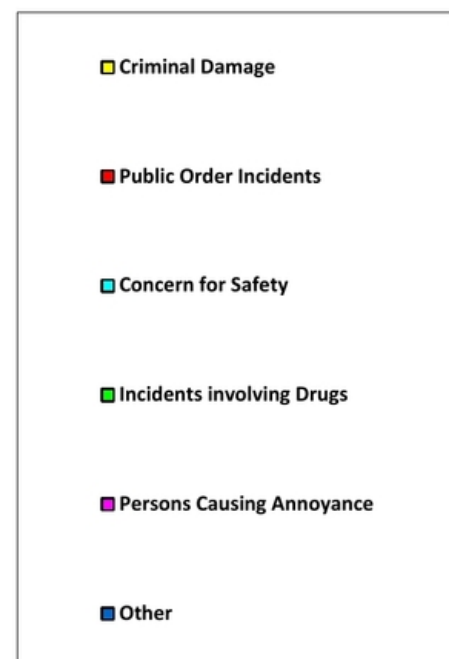
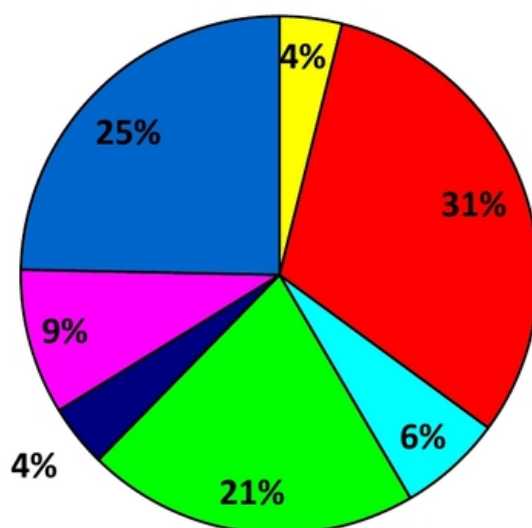
### Fixed Penalty Ticket / Discretionary Disposal

### Fixed Penalty Ticket / Discretionary Disposal 2017

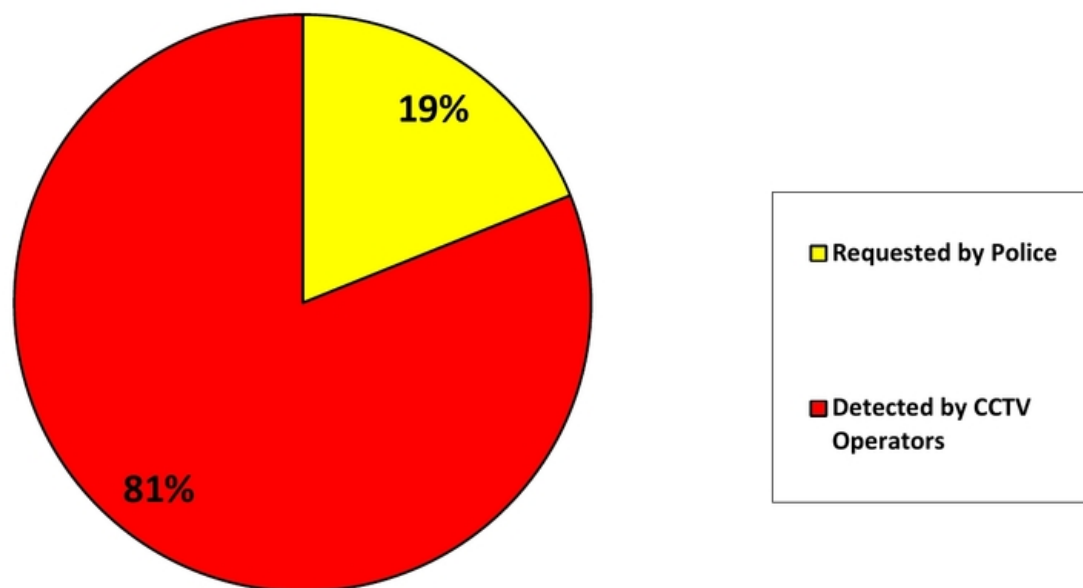

## Breif Incident Notes

- Down Control reports an assault which has taken place inside Whiskey Micks bar, the bar owner had informed police via 999 and reported that a known male had assaulted a male who was now unconscious outside, observations maintained on the crowd outside. The known male was located within the crowd, Down Control informed and various callsigns tasked. On arrival of DP70 the male looked to try and walk away but police were directed to the male who was quickly detained. Another callsign was then inside the bar and reported that a 2nd male was inside unconscious but breathing. Two ambulances were tasked. The known male was then arrested for two counts of AOABH.
- Observed a drunk and aggressive male, who had just been ejected from the Russell Bar in Downpatrick, who then proceeded to smash the windows of the bar. Down Control informed and DP70 tasked. The male then tried to smash more windows before the crew could arrive. He was stopped and Arrested for criminal damage.
- Observed a male defecating in the middle of Downs Road, Newcastle. Observations maintained on the male and DRC informed, DP71 tasked. The male went out of sight on Main Street before DP71 arrived. The crew checked the area but no sign of the male.

- Observed a male in a white shirt walk into an alleyway off Scotch Street Downpatrick with a few other males. The male in the white then produced a bag of white powder and started pouring it into the other male's hands. Observations maintained and Down Control informed and DP902 tasked. The call sign was directed to the male and to the bag which he dumped on seeing police. The male was stopped and arrested for Possession of Suspected Class A drug and Suspicion of supplying suspected Class A drug, he was notebook interviewed and released pending further enquires.
- Observations maintained on a known male and one other male standing around the side of the Russell Bar Downpatrick, the unknown male was seen to take a small bag of white powder out of the known males hands before then sniffing the contents. Down Control informed and DP71 tasked. The known male was then seen to make another exchange with a different male outside the Russell Bar. On arrival of DP71 the males friend told him that the callsign were walking towards him so he quickly ran back into the bar. The 2nd male believed to do an exchange with him was still standing outside, DP71 were directed to him. The male was searched and 3 small bags of suspected cocaine were found on his person he was then arrested, notebook interviewed and de-arrested. Details to be passed to the PPS.
- Observations maintained on a male and female acting a bit suspicious on Scotch Street Downpatrick. The male was then seen to produce a small plastic bag from his pocket before placing it into a different pocket. Shortly after the male was seen counting a large amount of cash and during this time the male and female were seen passing items to and from each other. The male then made a phone call and a 2nd male was then seen meeting up with him, an exchange took place between the two and Down Control was informed. DP70 tasked. Observations were maintained on the 1st male as the 2nd made his way out of sight. DP70 stopped the male and female and both were searched. The male was found to be in possession of a large amount of cannabis and cash, he was then arrested for Possession of Class B drug, the supply of Class B drug and Possession with Intent to Supply a Class B drug.
- Observed known a known male outside the Russell Bar Downpatrick giving a female a few snorts of a white powder. The female then got into Black Cleo which then went into the car park on Irish Street. Down Control informed who appeared uninterested and no call sign was tasked. DN503 then asked for details of the incident as they had overheard and they responded to the Russell and a few other persons were stopped and searched. The known male had left in a Silver Megane before police arrived.

- Observed the female from above again outside the Russell Bar. DN503 informed. Observed the female then drive out of the car park at the rear of the Russell Bar and head towards Irish Street car park, DN503 directed to the Black Cleo. The female driver was arrested for Driving Whilst Unfit.
- Observed a male with black hair slicked back and black bomber jacket produce what looked like a bag of white powder and give a male 2 snorts outside the Russell Bar Church Street Downpartick. Observations maintained and Down Control informed who tasked DP71. The male then got into a Silver BMW which then made its way to Meadowlands, DP71 informed. At 00:26 the male returned to the Russell bar and DP71 informed. The male made his way to the rear of the bar with another male who made off on police arrival but was detained by TSG Graphite 4. The male in the black coat was searched but nothing found. The male that was stopped by the TSG was wanted for Breach of Bail, he was then arrested for Breach of Bail.
- Down Control circulated details of a male trying to break the window of Diamond Pats Bar Newcastle. CCTV was reviewed and the incident was captured. The male is first seen approaching the bar at 00:29.13. A description was then requested by DP78 as they believed they may know who it was done it, cameras reviewed a description was given. The male was then located by the crews and arrested for criminal damage.
- Observed a male outside Quinn's Bar on Main Street Newcastle showing off a black coloured bag of suspected drugs that he then put down the front of his jeans. The male could then be seen showing off a bag of white powder he took from down the front of his jeans. Called Down Control twice but no reply so any available call sign was requested and DP77 responded. The male was constantly checking the legs of his jeans to see if anything was falling down from his groin area. The male made off on Police arrival but was detained near the beach. A search found the black bag which contained cannabis but no white powder could be located. The male was Arrested for Possession of class B drugs, interviewed and then released. He was later seen back outside Quinn's Bar at 0210 hours.
- Observed a female dragging another female around to the back of Quinns bar. The female was also seen to throw a punch at the other female. Down Control informed and DP902/903 tasked. The offender then made off and was seen entering the graveyard on Downs Rd, crews updated. On arrival of the crews an ambulance was requested immediately as the female had a head injury, this was later cancelled as the female said her friend was coming to pick her up, the offender was then located in the graveyard hiding and was later arrested for common assault.

One male was knocked out and a number of others punched and kicked. All callsigns informed including a number of officers who were standing near Quinn's Bar. The fighting continued sporadically after police arrival and other crews had to attend. One male who had punched another male to the ground was pointed out to DP31 and his details noted. Another male was arrested for A.O.A.B.H.
- Down Control reported a suspect DIC in a Black VW Passat parked near to Diamond Pats in Newcastle. Area checked and observed a blue Passat parked up across from Diamond Pats. Down Control informed. At 02:04 observed 2 males and a female getting into the Passat and driving off. All call signs informed of the direction of the Passat. Observed the Passat then make its way back to Main Street and all call signs informed. The vehicle was stooped just up from Quinn's Bar. The driver was arrested for Driving with Excess Alcohol and Possession of Class A drugs, the passenger was also arrested for Possession of Class A drugs.
- Observed a male and female having an argument at the top of Windmill Street, Ballynahinch. The male was preventing the female from leaving. Observations maintained and Down Control informed. The female did not wish to make a complaint but the male was arrested for Disorderly Behaviour and Resisting Arrest.
- Observed a male in a green checked shirt give a male in a white shirt a sniff of a white powder from a small bag with a tube attached in Market Street, Downpatrick. Down Control informed and DP70 tasked. The callsign was directed to the male who was stopped and searched. The bag with suspected Class A was recovered and the male made a full admission no further update was given.
- Observed 3 males in Church Street Downpatrick snorting a white powder from small bags. One of the males then made his way back into the Russell Bar while the other male made his way into Market Street. Down Control informed and DP70 tasked. DP70 informed that the male had placed the bag into his right hand coat pocket; despite this the officer did not search the males pocket and let the male go stating that he had been searched and nothing was found. NFTR
- Observed a male in a green hooded top holding a bag of white powder in his hand outside the Russell Bar. Down Control was informed and DP70 tasked. As the call sign arrived the male can be seen concealing the items down the front of his jeans. The call sign was informed of this and after a very poor search the items was not located and the male went on his way. NFTR



- Observed a known male hand over money to a male in exchange for a bag of white powder. Observations maintained on the pair and Down Control informed and DN500 tasked. The known male made his way into the Russell Bar while the male supplying made his way into The Central Bar. DN500 informed and description given. The male was stopped and searched in the bar with negative result. N500 stated that the male would have had time to dispose of any drugs before being searched. NFTR
- Observed a suspicious looking male on a pushbike hanging about on Railway Street Newcastle. A male in a black shirt and trousers then came out of the Cinnamon Indian Restaurant and met up with the male and both tried to go out of sight at the side of the Post Office. A suspected drugs deal was then observed between the pair with the male in the black shirt handing over a large sum of bank notes and the male on the bike passing a package which appeared to be a large clear bag with numerous small white raps inside. Both then split up with the male on the bike out of view towards Dundrum Road and the male in the black shirt making his way back into Cinnamon Restaurant. Down Control informed who updated that there was no callsigns free due to change over. Observations maintained on the Cinnamon Restaurant and at 2243 hours the male left again. Down Control informed and DP78 nights were tasked from Downpatrick but stated they would be 20 minutes. The male then made his way along the sea front towards Central Promenade and then went out of view towards Park Avenue. DP78 updated and also given the description of the dealer but no further sightings.
