1. Apologies and Chairman's Remarks

Apologies were received from Councillors Gallagher, Ruane, Savage, Trainor and Ruth Allen, SHSCT.

Councillor Hearty welcomed all to the meeting, in particular Wendy Osborne and Sarah Reid from the Policing Board and Shauna Rodgers from the Department of Justice.

2. Minutes of Policing Committee Meeting held on 28 May 2019

Read: Minutes of Policing Committee Meeting held on 28 May 2019 (copy circulated)

Agreed: On the proposal of Councillor Walker, seconded by Ms. Kelly it was agreed to approve the Minutes of the Policing Committee Meeting as a true and accurate record.

3. Matters Arising

Ms Kelly referred to a previous Policing Committee Meeting where it had been agreed to write to the CEO of Council regarding the installation of Rapid Bins on Council premises and asked if a reply had been received.

Ms Flynn replied that she had sent a letter to the CEO of Council on 16 May, an internal risk assessment had been initiated at the beginning of June and contact had been made with the Council's insurance broker.

Discussion took place and the following issues were raised:

- Disappointment expressed among some Members that the process was very slow, however Ms Flynn advised this was unavoidable as Council protocol had to be adhered to.
- It had been agreed the letter should be sent to the CEO as he would have to decide which Committee the item would be referred to.
- The CEO had been made aware of, in the letter, of the desire of the PCSP to have the matter explored.
- A copy of any relevant correspondence should be made available to the Members if requested.
- A fourth Rapid Bin was to be installed the following day at the Ballymote Centre, Downpatrick,

4. Declarations of Interest

There were no Declarations of Interest.

5. District Commander's Report – Period 3

Read: District Commander's Report – 30 July 2019 (copy circulated)

Chief Inspector Joe McMinn presented the District Commander's report to the Committee.

Following the presentation, discussion took place and the following points were raised:

General

- The format of the District Commander's Report was not broken down into individual DEA areas, but if required, Sergeants could provide updates via local groups.

Mental Health

- A Community Support Partnership had been established with partner agencies to tackle various issues of mental health, including vulnerability, the details of which had been included in the May 2019 PCSP Officer Report.

- Inspector Vogan was the single point of contact for hospitals regarding any issues pertaining to alcohol, drug abuse and mental health, and agreement had been reached with the Health Trust on the correct protocol to follow.
- The Health Trust endeavoured to have assessments completed within 4 – 6 hours, however this was case dependent and not always possible. Police officers could be required to conduct a risk assessment and sit with patients in the hospital until they were seen.

Traffic Management

- The concerns raised regarding speeding and cars parking at Bloody Bridge were difficult to resolve in terms of installing road calming measures as there was protocol to be followed. Insurance companies could promote speed tracking devices in an effort to reduce speeding offences.
- Traffic offences regularly occurred in the Crossmaglen area and phone calls through to 101 had not been answered. Chief Inspector McMinn expressed disappointment at this saying it was not acceptable.
- A recent incident of car racing in Greenbank had resulted in a call being made to 101, the call was answered, a case reference number was given to the caller and it was followed up by PSNI to the caller's satisfaction.

Parades

- PSNI could not comment on individual cases.
- Organisers of parades were required to submit an 11/1 form to PSNI, a risk assessment was then conducted and if deemed not to require PSNI presence, organisers notified to that effect.
- Organisers had ultimate responsibility for parades.
- If PSNI had reason to believe there may be a risk at a parade, e.g. if there was a bad bend on the route then PSNI would be deployed.
- Inspector Russell to report back to Councillor Walker as to a parade he had referred to where the organisers had completed an 11/1 form but had not been notified that the PSNI would not be present.

Internet Safety

- Difficulty in getting people to attend public information sessions on Internet Safety, PSNI currently trying to address this issue.
- Internet scamming techniques getting more sophisticated, vigilance required with personal details.

Police Resources

- PSNI confirmed there was a full quota of officers over all the DEA areas.

Point of Clarity (Re: Agenda Item 3, Matters Arising)

Ms Flynn and Mr Brannigan provided clarification on the following issue:

Rapid Bins – At the January 2019 Meeting, there had been a misunderstanding regarding the location for a Rapid Bin and some Members understood it had been agreed to locate one at Newry Leisure Centre, which was not the case. It had subsequently been agreed at the March 2019 Policing Committee Meeting that a letter be sent to the CEO of Council, this had been done ensuring full Council protocol had been followed.

The fourth Rapid Bin was to be installed the following day which would mean there were now Rapid Bins located in Kilkeel, Newry, Camlough and Downpatrick. Three of these have been installed since the March meeting.

6. Date of Next Meeting

It was agreed the date of the next meeting would be Wednesday 18 September 2019 at 6pm in the Boardroom, Council Offices, Newry.

There being no further business, the meeting concluded at 6.55pm.

Executive Summary:

Victim Update and Support:- 97.7% of 4577 victims of crime have received an update from Police within the 10 day target. This figure remains consistent.

Community Engagement:- July & August have seen us being involved in a number of parades, festivals and other events. Feedback has been largely positive, and our Neighbourhood & Local Policing Teams have used these events as opportunities to engage.

Anti-Social Behaviour:- There has been an overall general decline in the total number of ASB reports across the District in July and August of this year compared to last. July has seen an increase of ASB in each Sector compared to June, coinciding with the end of the school term and warmer weather.

In each Sector, those affected by ASB are encouraged to report incidents via the normal channels in order to record a true reflection of what is happening in each area.

Inspector Hardy has provided a useful table in the report.

There has been positive interaction with youths that have caused concern in the Downpatrick area.

Hate Crime:- There has been an increase in reported hate incidents from 12 in May and June to 29 in July and August. There is no change on the reported number of hate crimes or incidents over the same period last year. The majority of reports were sectarian in nature (12) closely followed by racial (10). In most cases, these were either first time reports, matters being reported by a third party, or in a small number of cases, issues that

have been ongoing and are being progressed through the criminal justice system.

Domestic Abuse:- There has been an increase in reports of domestic incidents. This increase is in line with national figures and highlights an increase in confidence for victims reporting these matters.

We are planning a substantial training exercise in conjunction with Women's Aid and PCSP. Details are in the body of the report. We appreciate the difficulties faced by victims of Domestic Abuse. We focus on achieving excellent investigations which can withstand the withdrawal of a victim's cooperation in proceedings that require a prosecution in the public's interest.

Vulnerability:- Our Crime Prevention Officer has continued to visit victims of crime offering practical tips and piece of mind. We are in discussions with "Good Morning" service provider with a view to maximising referral pathways to the service.

Neighbourhood officers have attended a number of residential programmes with minority/inclusion groups.

The District Community Support Partnership has had three operational meetings to date. We have made significant strides in improving the circumstances of some of our most vulnerable people. Our latest meeting has seen the Community & Voluntary Sector take their place in our partnership. This sets us apart from Support Hubs across the Province and already we can see huge value in their participation.

Crime:- Total police recorded crimes for The financial year thru July are 2724. This is a marginal increase (1.4%) on last year's figures. Detailed figures are included in the report. Police joined PCSP in a "Pop up" Crime Prevention shop in the Buttercrane Centre, Newry in August. This was hugely successful with in excess of 250 security packs handed out to members of the public.

Road Safety:- Latest verified motoring offences are included in the report. Detections rose by 27% for the FYTD to June 30th in comparison with 2018.

We are in discussion in relation to rolling out "Kids Court" in a number of schools across

the district.

Roadsafe priorities for this period were Excess Speed & Drink/Drug Driving.

Drugs:- We now have four RAPID bins installed in our district. The Camlough bin was emptied for the first time during this period and contained 1400 items. Contents were predominantly prescription and over the counter medication.

Our teams have engaged with youths at a number of festivals in this reporting period, they have warned about the dangers associated with drugs and a number of searches & seizures were carried out.

Newry DEA continues to have the highest number of ASB incidents reported in Newry LPC, mainly occurring in the Ballybot ward (50 in total over the two months, although this is a reduction on the previous two months.) Within Downpatrick LPC, the majority of reports are found in the Downpatrick DEA, with 78 incidents this year, mainly occurring in the Cathedral and Knocknashinna wards (KNocknashinna showed a decrease in reported incidents in August, from 27 to 18) Newtownhamilton and Crossmaglen have the fewest reports of ASB in the District (Crossmaglen shows only single figures)

Over the summer months NPT were conducting beat patrols in areas affected by increased ASB. The team was also detailed at a number of parades. We carried out a number of interagency and multi-agency meetings over the reporting period.

A public meeting was held on 17.07.19 at the leisure centre in Saintfield organised by local political reps and attended by residents, PSNI, NIHE, PCSP to address issues of concern around ASB in the town.

ASB meeting Ballymote centre 25.07.19 and with the Down Community Collective on 1.08.19

NPT assisted at Strangford in relation to the Portaferry Gala on 19.07.19

RADAR 08.08.19 – six youths from Model Farm/ Flying Horse taken to RADAR where interactive engagements took place to illustrate the consequences of criminal damage, putting them in the place of the victim. Youths identified at being of risk of causing ASB took part in a week long Actisport scheme from 12th August, with some also attending Life Adventure Castlewellan.

DEA event Castlewellan on 22.08.19 in relation to Spanner in the Works theatre company covering topics around drugs, alcohol, domestic violence.

A meeting was conducted with representatives from the Downpatrick Community Collective and PSNI will be meeting up to discuss ongoing issues regarding ASB within Downpatrick following on

from the successful meetings between town centre business owners and PSNI over the past year. There are still issues within the town centre in relation to ASB however the focus has moved back towards the estates, especially in July. Previous types of ASB have been reported as had been reported previously, with items being set on fire, NIFRS and passing vehicles having stones thrown at them, and a serious incident at the leisure centre where youths set a fire and threw items at a group of persons attending a class at the leisure centre. This continues to be a live investigation. All areas continue to be the focus of attention of LPTs and NPT when not attending calls for service.

In Rowallane, meetings have been set up with local residents by PCSP members. A meeting took place in Saintfield along the same lines as the previous one in Killyleagh. This was a well-attended and useful meeting with an exchange of views, where actual police response was reported on a favourable level, however concerns were raised in relation to the type, and volume, of ASB in the town. As with Killyleagh, the number of incidents being talked about on the night were much greater than the actual number reported, and residents were encouraged to report incidents as they occurred.

Within Slieve Croob and Mourne, local crews have been tasked to carry out beat patrols in areas of concern identified both by incident reports as well as information provided by representatives.

	<p>Our district shows an 11.9% increase in Domestic Abuse Crimes reported. This is compared with the national increase of 9.9%.</p> <p>We work closely with statutory and voluntary agencies to ensure victims get the help they need, to highlight the issue of Domestic Abuse and to explore ways in which we can keep people safe. In addition to uniformed officers trained to respond to and investigate domestic incidents, PSNI also has dedicated domestic abuse officers across Northern Ireland to ensure all domestic abuse crimes are investigated, as well as providing support and information to victims about police procedures and legal proceedings.</p> <p>Building on familiarisation sessions with Women's Aid earlier in the year, we are working in partnership with the PCSP and Women's Aid to develop further bespoke training.</p> <p>The Course is OCN Level 2 accredited in Preventing and tackling domestic and sexual abuse / violence – see link at https://www.ocnni.org.uk/qualifications/nocn-level-2-award-in-preventing-and-tackling-domestic-and-sexual-abuseviolence/</p> <p>The training will take place over a full day in a group of around 8-12 persons. All coursework and evidence is produced on the day and verified by Women's Aid, who will deliver the training</p> <p>It is envisaged that the training will take place from late October onwards and plans are currently being finalised.</p>
