## Parks Survey

The Newry, Mourne and Down District Council area is well recognised for the quality of our outdoor environment. Across the district local residents and visitors have the benefit of being able to access high-quality forest parks, country park and green spaces. There is increasing public awareness of the value of good-quality forests, parks and green spaces in improving the quality of life for our residents and visitors. Forests and country parks have many uses, including appreciating wildlife; natural and cultural heritage; relaxation, peace and quiet; opportunities to take part in both exhilarating and gentle outdoor recreation activities, enjoying the company of family and friends, or enjoying solitude. With a growing emphasis on recreation and leisure, forests and parks are now playing an ever more important role in providing amenities and enhancing people's quality of life.

Within the district, the Council manages the recreation and tourism provision at 4 Forest and Country Parks (Castlewellan, Kilbroney Park, Delamont Country Park and Slieve Gullion Forest Park) which collectively attract in excess of one million visitors per annum.

As the number of residents and visitors using our Forest and Country Parks continue to increase, the Council is committed to ensuring the long-term sustainability of these spaces.
