



## **Newry, Mourne and Down District Council Irish Language Bursary Scheme 2020/2021**

### **Guidance for Applicants**

#### **Purpose of the Bursary Scheme**

To assist individuals who have not been awarded a scholarship / bursary from public funds to improve Irish Language skills through providing scholarships or bursaries for Irish Language courses, including Gaeltacht colleges and intensive courses which begin and finish within the period under consideration (Call 1: 3 August 2020 – 30 September 2020 or Call 2: 01 October 2020 – 31 March 2021).

The bursary will cover course fees only.

Applicants are eligible to apply for 50% of total fees for the course up to a maximum of £300 in total.

Retrospective applications will not be considered. Only one bursary offer per person per financial year is permitted (3<sup>rd</sup> August 2020 – 31<sup>st</sup> March 2021).

#### **Applications received before the opening date of 3<sup>rd</sup> August 2020 will not be considered**

The applicant must:

- be resident in the Newry, Mourne and Down District Council area;
- in the case of minors, have parental / guardian permission to attend the Irish Language course;
- be registered to attend an Irish Language course;
- not already have a scholarship from public funds (eg Líofo Bursary);<sup>1</sup>
- complete the Irish Language course by attending for its duration;
- provide proof of full payment of fees and attendance at the Irish Language course

#### **The application process**

Application forms will be available to download from the Newry, Mourne and Down District Council website [www.newrymournedown.org/gaeilge](http://www.newrymournedown.org/gaeilge)

This is a rolling scheme. All applicants will be required to supply accurate contact details to enable effective communication regarding the progress of their bursary application.

The Council will make the final decision on the allocation subject to applicants meeting the eligibility criteria. Successful applicants will be informed of the amount of their individual bursary, which will be awarded only upon successful completion of the course and having met the conditions of the letter of offer. While applicants are eligible to apply for 50% of total fees for the course up to a maximum of £300 in total, the number of individual bursaries awarded will be dependent upon the level of funding available.
