



## **Public Consultation on Warrenpoint Breakwater Upgrade Scheme – Consultation Period Extended to 26 November 2021**

### **Introduction to Proposed Scheme**

Investing in regeneration, modern infrastructure and connectivity is a key strategic priority for Newry, Mourne and Down District Council under its Economic and Regeneration Development Strategy.

The Warrenpoint Breakwater Upgrade scheme is a key priority under the strategy through enhancing and creating a more vibrant public space along the Front Shore area. To this end, the Council has been working in partnership with the Department for Communities South Eastern Regeneration Office to develop and secure funding for the project.

Please note, the consultation carried out earlier this year on the 'Warrenpoint Front Shore Public Realm Scheme' did not include the Breakwater, which will now proceed as a separately proposed project with its own Public Consultation process now being undertaken.

The main Warrenpoint Front Shore Public Realm Scheme, excluding the Breakwater as previously referred to, is now going through the planning process.

## The Project

The aim of the Breakwater Upgrade Scheme is to build on and connect with the already consulted on Warrenpoint Front Shore Public Realm Scheme.

Its key aim is to enhance the aesthetic appearance, usage and key infrastructure within the expanse of the breakwater, from its entrance at Osbourne Terrace, to the head of the Breakwater at the water's edge overlooking the Shipping Channel.

The proposed works include:

- a replacement of lighting columns which are either missing, damaged and weather beaten
- a replacement of street furniture including bins and benches
- enhancement of the existing entrance area to increase its pedestrian connectivity and flexibility of use
- provision of lettable kiosk/vendor space to enhance the provision for users of the Front Shore
- improvement of pedestrian linkages along the Breakwater through replacement of the existing surface.

The project is planned to commence in early 2022, subject to securing planning approvals and the award of funding from the Department for Communities.

### **Scope of the Proposed Scheme**

This project only covers the Breakwater from its entrance area just off Osbourne Terrace along its 180 metres to the Water's edge overlooking the Shipping Channel.

Given the previously consulted on Warrenpoint Front Shore Public Realm Scheme, that scheme is **not** part of this Breakwater consultation exercise. The Warrenpoint Front Shore (Dock Street Corner to Slieve Foy Place) Public Realm Scheme is now about to go through the planning process and, subject to this permission and funding being confirmed, should be in a position to go onsite in 2022.

The re-development of the Public Baths is **not** part of this scheme and is therefore not part of this consultation. The public consultation undertaken earlier in 2021 for the Front Shore Public Realm Scheme received significant feedback relating to the re-development of the Public Baths. This has been fed through to the Council, with the Baths being taken forward as a separate initiative.
