#### **Privacy Notice**

#### **Purpose:**

Newry, Mourne and Down District Council (NMDDC) is collecting the information on this competition answer sheet to enable it to run the Downpatrick Household Recycling Centre Schools' Competition.

#### **Legal basis for processing:**

The legal basis we rely on to process your personal data is article 6(1)(f) of the General Data Protection Regulation. This article allows us to process personal data when its necessary for the purposes of our legitimate interests, which in this case is the promotion and/or protection of environmental matters.

#### What we need:

We need every pupil who is taking part in the competition to visit the site, accompanied by a <u>parent / guardian or a responsible adult</u>, and to bring this sheet with them. Pupils should complete their contact details, to include their name, school name, post code (if known) and class, as well as answer the five competition guestions posed.

#### Why we need it:

We need the pupil's name, school name, post code (if known) and class so that we can contact their school if they are one of the winners in the competition. Winning pupils will be invited to attend a prizegiving at a date to be confirmed.

We need the pupils' answer sheet so that it can be included in the competition draw.

#### What we do with it:

We will include every correct answer sheet in the competition draw. We will draw the winners before 29 November 2019 and will contact the winners' school to inform them that their pupil is a winner.

#### How long we keep it:

We will keep the entries until the Competition ends on 29 November 2019 and the winning entries have been drawn. Once the winners have been drawn all other entries will be destroyed.

We will retain the winners' personal data until 31 December 2019 at which time it will be disposed of in accordance with NMDDC's disposal policy.

#### What are your rights:

You have the right to request access to the personal data that we hold about you.

You have the right to ask for your personal data to be rectified, or to restrict the way in which we process it.

You have the right to object to our processing of your personal data. There are legitimate reasons why we may refuse your objection, which depend on why we are processing it.

You have the right to ask us to erase your personal information in certain circumstances.

You have the right to complain to the Information Commissioners Officer if you are unhappy with the way in which we have processed your personal data.

#### Do we use any data processor:

We do not use any data processor for the purposes of the Downpatrick Household Recycling Centre Schools' Competition nor do we share data with any third party.
